Section 1 of the Civil Defence Act 1948 made it 'part of the functions of designated Ministers to take such steps as appear from time to time to be necessary or expedient for civil defence purposes.' By an Order in Council dated 28 July 1949, The Civil Defence (Designation of the Minister of Health) Order 1949 , the Minister of Health was designated responsible for a number of civil defence functions. These included control of medical manpower, care of the homeless and other refugees, emergency ambulance service, and civil defence arrangements in hospitals. This included the National Hospital Service Reserve which was established by the minister to provide a trained and organised body of men and women available to meet the needs of an expanded hospital service in the event of war.	1974
